AGENDA HEADING:

Subdivision improvement bond reduction for Summersfield Plat 1.

SYNOPSIS:

Recommend a \$10,787 reduction to the remaining subdivision improvement bond in the amount of \$29,765 for the Summersfield Plat 1 subdivision, since a further portion of the required improvements have been completed to the satisfaction of the Engineering Department. The remaining bond amount for improvements still requiring completion is \$18,978.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

On December 4, 2006, the City Council approved and accepted the original subdivision improvement bond for infrastructure improvements in the amount of \$75,913 for public sidewalk work in the Summersfield Plat 1 subdivision. On February 28, 2011, the City Council approved a reduction of the subdivision improvement bond to \$29,765 after a portion of the sidewalk improvements were completed. The developer has requested a further reduction of the required surety since additional subdivision improvement work has been completed. The installation of 1,190 lineal feet of four (4) feet wide public sidewalk is still remaining and will still require surety in the amount of \$18,978 to make certain that the remaining improvements will be in place when the development of the plat is completed.

Summersfield Plat 1 is located in the 4400 block of E. 46th Street and consists of 129 single-family residential lots and one (1) commercial lot on 44.65 acres. The developer of the property is Summersfield, LLC, 6900 Westown Parkway, West Des Moines, IA 50266, Steve Niebuhr, Senior Vice President.
