# AGENDA HEADING:

### SYNOPSIS:



- February 4, 2016, the City Plan and Zoning Commission voted to recommend to the City Council of the City of Des Moines, Iowa that a segment of West Martin Luther King, Jr. Parkway (formerly Elm Street), adjoining 300 West Martin Luther King, Jr. Parkway, be vacated, subject to reservation of easements for all existing utilities in place, including known water and sanitary sewer mains, until such time that they are abandoned or relocated.
- The property to be conveyed consists of approximately 5,044 square feet and the purchase price of \$12,610 is equal to the restricted-use fair market value of the property, as determined by the City's Real Estate Division.
