AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement with Shuck-Britson, Inc. for additional bridge aesthetic development and final aesthetic design services for Grand Avenue Bridge over Des Moines River, not to exceed \$160,193.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 1 to the Professional Services Agreement with Shuck-Britson, Inc., 400 E. Court Avenue, Suite 140, Des Moines, Iowa, 50309, not to exceed \$160,193, for additional bridge aesthetic development, final aesthetic design, and additional design services for Grand Avenue Bridge over Des Moines River.

ADDITIONAL INFORMATION:

On January 27, 2014, by Roll Call No. 14-0117, City Council approved a professional services agreement with Shuck-Britson, Inc. for design and construction phase services for the Grand Avenue over Des Moines River Bridge Replacement project. During the design process, the engagement of the Aesthetic Review Committee necessitated additional aesthetic development, which led to the need for final design services to incorporate the aesthetic elements into the bridge plan set. An architectural design sub-consultant was added to the consultant design team to assist in the development of numerous additional aesthetic design concepts, facilitation, and attendance at additional aesthetic review committee meetings, preparation of additional design details and specifications for the added aesthetic components of the bridge, and additional construction administration services. Also, additional final design services were requested based on design feedback from the constructability review meeting and ongoing regulatory permit coordination.
