

AGENDA HEADING:

Approving and authorizing the execution of Iowa Department of Transportation (IDOT) agreement for Citywide Fixed-Time Traffic Signal Upgrade Project—Phase 2.

SYNOPSIS:

Recommend approval of IDOT Agreement No. 2017-TS-002 for \$120,000 in Traffic Safety Improvement Program project funding for the Citywide Fixed-Time Traffic Signal Upgrade Project— Phase 2.

FISCAL IMPACT:

<u>Amount</u>: \$660,000


Funding Source: Various funding sources as follows:

- \$120,000: IDOT Traffic Safety Improvement Program Funds
- \$ 60,000: 2016-2017 CIP, Page Street 45, Traffic Signals, Channelization and School Crossings
- \$480,000: IDOT ICAAP Funds

ADDITIONAL INFORMATION:

The Citywide Fixed-Time Traffic Signal Upgrade Project—Phase 2 has been identified as a high priority project. The project provides for upgrading traffic signal operation at 25 existing intersections that currently operate as fixed-time signals.

This project has received IDOT Traffic Safety Improvement Program funds for a maximum amount of \$120,000 and IDOT ICAAP Funds for a maximum amount of \$480,000 (RC 15-1231, July 27, 2015), for a total of \$600,000. The remaining construction costs, design, inspection, and construction administration are to be funded by the City. The total City cost is estimated to be \$60,000.
