AGENDA HEADING:

Des Moines Asphalt & Paving Co. (Craig Lamberty, President) and Grimes Asphalt & Paving Corp. (Kurt Rasmussen, President) to revise the annual contract with two (2) additional 1-year renewal options to furnish hot mix asphalt materials as requested by the Public Works Department, increase in annual estimate \$400,000.

SYNOPSIS:

In March 2015 two (2) bids were received for hot mix asphalt products as specified by Public Works. These materials are for asphaltic paving restoration, neighborhood infrastructure rehabilitation and pothole patching.

FISCAL IMPACT:

Amount: \$400,000

Funding Source: 2015-16 CIP Pages; Street Improvements – 4 ST003 Asphaltic Paving Restoration Program and Street Improvements – 24 ST205 Neighborhood Infrastructure Rehabilitation Program and Operating Budget, S360 PW240402, Street Maintenance Fund page 238.

ADDITIONAL INFORMATION:

Hot mix asphalt overlays are an effective maintenance solution for a moderately stressed pavement. The new driving surface allows the renewal of the roadway for a 15-20 year period. At some point, traffic loading stresses accumulate on the original street base resulting in base failures on the street.

The additional asphaltic material will also be used to complete more substantial spot repairs on existing overlays. For example on major roadways with heavy bus traffic, sometimes there is rutting or shoving of the asphalt in the curb lane for 25 to 50 feet. This additional asphalt material will enable Public Works crews to address the spot repair.

The additional Road Use Tax will help to fund these base repairs. This will result in a longer service life for the newly overlaid surface.
