# AGENDA HEADING:

Approval of budget for the Friends of SW 9th and advancement of funds for SW 9th revitalization projects.

### SYNOPSIS:

On August 10, 2015, by Roll Call No. 15-1353, City Council approved a proposal for sale of City owned land at 849 Army Post Road to Hurd Quality, LLC (Richard Hurd, Manager, 2000 Fuller Road West Des Moines, Iowa 50265) with the direction that \$220,000 of the \$260,000 in land sale proceeds be placed in an account for use on SW 9th Street revitalization projects by the Friends of SW 9th (Glenn Lyons, President, 3209 Ingersoll #205, Des Moines, Iowa 50312).

Closing has occurred on the sale of land and designated funds can now be transferred to the Friends of SW 9th. The group's budget prioritizes the use of these funds for façade grants and other projects that will assist in the revitalization of the SW 9th corridor.

The Friends of SW 9<sup>th</sup> will need to submit itemized requests for payment as expenses are incurred and City Finance Department will process the reimbursements.

#### <u>Amount</u>: \$220,000

<u>Funding Source</u>: CMO22000 Economic Development Enterprise Account; proceeds from sale of land at 849 SW 9th to Hurd Quality, LLC.

# **ADDITIONAL INFORMATION:**

- The Friends of SW 9th is made up of membership from numerous neighborhood and business groups working for revitalization along the five (5) mile SW 9th corridor.
- Several sites in blighted or deteriorated condition have been identified along the corridor for targeted re-investment, with specific efforts initiated at 2619 SW 9th and 2440 SW 9th.
- Reporting requirements back to the city for the use of the funds will be finalized by the City and the Friends of SW 9<sup>th</sup>
