#### **AGENDA HEADING:**

Approving Change Order No. 1 with Cramer and Associates, Inc. for additional work on the S.W. 5th Street (Jackson Avenue) Bridge Rehabilitation, in an amount not to exceed \$63,323.

#### **SYNOPSIS:**

Recommend approval of Change Order No. 1 in an amount not to exceed \$63,323 with Cramer and Associates, Inc., Robert Cramer, President/CAO, 3100 S.W. Brookside Drive, Grimes, IA, 50111, for additional work on the S.W. 5th Street (Jackson Avenue) Bridge Rehabilitation, for additional structural steel repair work and painting of new utility conduit.

#### FISCAL IMPACT:

Amount: \$63,323

Funding Source: 2016-2017 CIP, Page Parks - 8, Multi-Use Trail Bridges, PK177, Being: \$11,000

reimbursement from Verizon; \$52,323, PK177, G.O. Bonds

#### ADDITIONAL INFORMATION:

During structural steel shop drawing review and field observation, modifications were made to some of the structural repair details to accommodate field conditions. Additional corrosion was discovered in areas which were not previously accessible.

Verizon installed six (6) inches of diameter conduit on the bridge which will be painted with the remainder of the bridge to match. This cost is being reimbursed by Verizon.
