AGENDA HEADING:



ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Women of Achievement Bridge Deck Surface Replacement, 12-2016-002. The improvement includes sand blasting, non-skid surface application, painting, caulking, and pedestrian traffic control; all in accordance with the contract documents including Plan File Nos. 573-083/088, located on the Women of Achievement Bridge over the Des Moines River at Center Street, Des Moines, Iowa. The material is being provided at no cost to the City as part of the original project warranty.

The estimated construction cost is \$160,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
