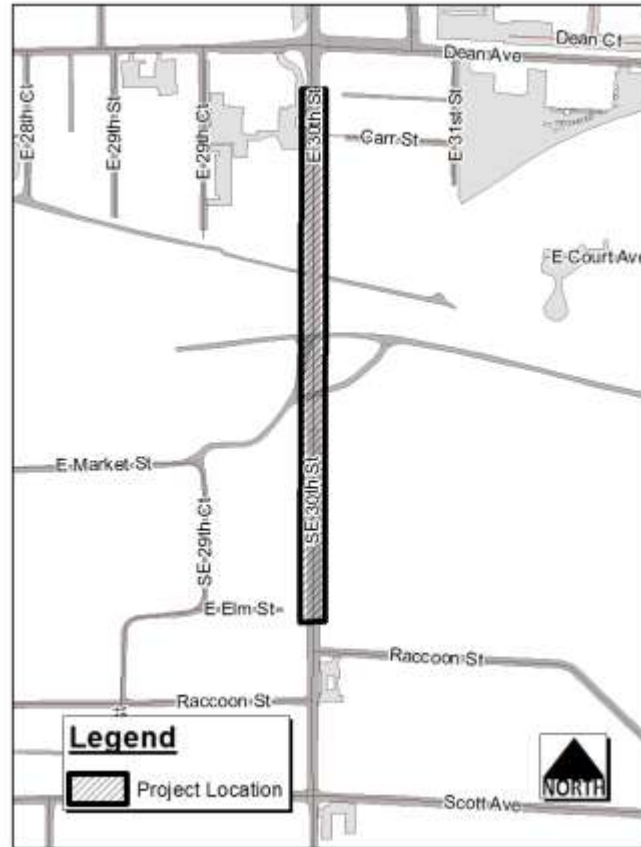
Funding Source: Various funding sources as follows:

- \$3,900,000: 2016-2017 CIP, Page Bridge-14, Structural Repair—Corrosion Protection, BR039, G.O. Bonds.

ADDITIONAL INFORMATION:

The E 30th Street Viaduct over UPRR Rehabilitation project has been identified as a high priority project for corridor safety improvements in the Citywide Bridges and Structure Evaluation. The project provides for repairs to the E 30th Street Bridge over the UPRR.

This project has received IDOT Surface Transportation Program funds for a maximum amount of \$1,000,000 allocated by the Des Moines Area Metropolitan Planning Organization for FY 2019. On February 8, 2016, under Roll Call No. 16-0183, the City Council approved and authorized execution of IDOT Agreement No. 1-15-HBRR-005 for \$1,000,000 in Highway Bridge Program project funding. The remaining construction costs, design, inspection, and construction administration are to be funded by the City. The total City cost is estimated to be \$3,900,000.
