AGENDA HEADING:

Community Development Block Grant (CDBG) funding for Impact Community Action Partnership.

SYNOPSIS:

Approve CDBG funding allocation and authorize the City Manager to execute an agreement with Impact Community Action Partnership.

FISCAL IMPACT:

Amount: \$66,624.87 from 2015 CDBG funding; \$200,000 from 2016 CDBG funding; \$150,000 from 2017 CDBG funding; \$100,000 from 2018 CDBG funding; and \$50,000 in 2019 CDBG funding and every year after.

<u>Funding Source</u>: 2015-2016 Operating Budget, Community Development Department, Special Revenue Fund, Community Development Block Grants, page 57.

ADDITIONAL INFORMATION:

On May 18, 2015, the City Council approved the Assumption Agreement by and between the City of Des Moines and the Red Rock Area Community Action Program for the conveyance of the Des Moines Community Action Agency programs and service area. As a part of this agreement, CDBG funding will be phased down as follows:

2015 - \$66,624.87 (remaining funding as a City operation)

2016 - \$200,000

2017 - \$150,000

2018 - \$100,000

2019 and every year after - \$50,000

With approval of this allocation of funding, it is recommended that Council authorize the City Manager to execute a contract with Impact Community Action Partnership for this funding.
