AGENDA HEADING:

Approving the purchase of additional services to relocate the voting and audio systems for the City Hall Council Chambers from Triad Productions, Inc.

SYNOPSIS:

Recommend approval of Change Order No. 1 in an amount not to exceed \$11,952.43 with Triad Productions, Inc., Dick Trump, President, 1910 Ingersoll Avenue, Des Moines, IA 50309.

ADDITIONAL INFORMATION:

City staff was directed to provide a Council meeting area at the Municipal Service Center building during the renovation of City Hall and to make provisions so the City Council meetings and other meetings would continue to be recorded and broadcast on television, specifically Mediacom Channel 7. In coordination with the physical development of a new dias, stage, and Council ready room, accommodations were made to move the Public Information Office into an adjacent room to the new Council Chambers to facilitate this request.

The complexity of adapting the existing City-owned portable audio system to the existing equipment at the Municipal Service Center system proved more complicated than was expected. An original contingency of 10% was anticipated to be sufficient at the time of the initial bid, but the project had an overrun. This was based on equipment failure prior to the move, a power failure that occurred at the Municipal Services Center, and some changes to the voting system to ensure a smooth recovery in time for the next Council meeting.
