AGENDA HEADING:

Hearing on Municipal Buildings Reroofing - Contract 2. Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Brazos Urethane, Inc., Howard W. Scoggins, III, President, \$183,457.

SYNOPSIS:

This is a public hearing to allow for public input on the Municipal Buildings Reroofing - Contract 2 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the repair of three (3) municipal building roofs that have deteriorated resulting in leaks throughout the buildings.


ADDITIONAL INFORMATION:

On June 27, 2016, under Roll Call No. 16-1017, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Municipal Buildings Reroofing - Contract 2. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Municipal Buildings Reroofing - Contract 2, 10-2016-008. The improvement includes the repair of the existing roofing materials and installation of a sprayed polyurethane foam roof on three (3) municipal buildings; all work in accordance with the contract documents including Plan File Nos. 574-008/014, located at Public Works Sign Shop - 216 S.E. 5th Street, Armory Building – 602 Robert D. Ray Drive, and Glendale Cemetery Abbey – 4909 University Avenue, in Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

Brazos Urethane, Inc., Texas City, TX Southern Minnesota Urethanes, LLC, Caledonia, MN The bids were received and opened at a public meeting presided over by the City Engineer in the Shijiazhuang Room, 2nd Floor, City Administration Building, 400 E. Court Avenue, Des Moines, Iowa at 11:00 a.m. on July 12, 2016.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Brazos Urethane, Inc., Howard W. Scoggins, III, President, 1031 6th Street North, Texas City, TX, 77590 in the amount of \$183,457, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
