AGENDA HEADING:

Approving purchase of 30 vehicles off of the State of Iowa Contract for use by Police and Fire Departments.

SYNOPSIS:

Recommend the purchase of 25 Ford Interceptor Utility and one (1) Ford Interceptor Sedan vehicles for use in the Police Department and two (2) Ford Interceptor Utility and two (2) Ford Expedition vehicles for use in the Fire Department utilizing the State of Iowa Department of Administrative Services vehicle purchase contract from Stivers Ford, 1450 E. Hickman Road, Waukee, Iowa 50263 (Scott Politte, General Manager) in the amount of \$820,447.52.

FISCAL IMPACT:

Amount: \$820,447.52.

ADDITIONAL INFORMATION:

Recent annual comparisons of state contract purchases compared to competitive bid vehicles have yielded cost savings by utilizing the State of Iowa Department of Administrative Services vehicle purchasing contracts. In addition to cost savings, in many cases competing dealers will not submit bids against established State of Iowa Contract holders. Therefore, staff has implemented the practice of utilizing the state contract when there is a specific fit of vehicles to a particular application. These replacement vehicles are all front line, up fitted for emergency responses and use one (1) of the various configurations available through of the State of Iowa vehicle purchase contract.

The Fleet Oversight Committee (FOC) has determined this group of replacement vehicles either meet or exceed established replacement criteria. FOC authorized the full proposal of 30 new replacement City Fleet vehicles

Purchase of these vehicles is recommended utilizing the State of Iowa contract.
