AGENDA HEADING:

Hearing on Municipal Buildings Reroofing - Contract 1. Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Brockway Mechanical & Roofing Company, Inc., Ryan M. Brockway, Vice President, \$252,200.

SYNOPSIS:

This is a public hearing to allow for public input on the Municipal Buildings Reroofing - Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the replacement of two (2) municipal building roofs that have deteriorated resulting in leaks throughout the buildings.


On July 11, 2016, under Roll Call No. 16-1099, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Municipal Buildings Reroofing - Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Municipal Buildings Reroofing - Contract 1, 10-2016-007. The improvement includes the complete removal of the existing roofing materials and installation of a fully adhered white ethylene propylene diene terpolymer (EPDM) roof on two (2) municipal buildings; all work in accordance with the contract documents including Plan File Nos. 574-001/004, located at Parks Warehouse, 1300 Scott Avenue and Public Works Out Building, 216 S.E. 5th Street, all in Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

- Brockway Mechanical & Roofing Company, Inc., Burlington, IA
- Academy Roofing & Sheet Metal of the Midwest, Inc. dba Academy Roofing & Sheet Metal Co., Des Moines, IA

The bids were received and opened at a public meeting presided over by the City Engineer in the Shijiazhuang Room, 2nd Floor, City Administration Building, 400 E. Court Avenue, Des Moines, Iowa at 11:00 a.m. on July 26, 2016.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Brockway Mechanical & Roofing Company, Inc., Ryan M. Brockway, Vice President, 1025 Osborn Street, Burlington, IA, 52601 in the amount of \$252,200, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
