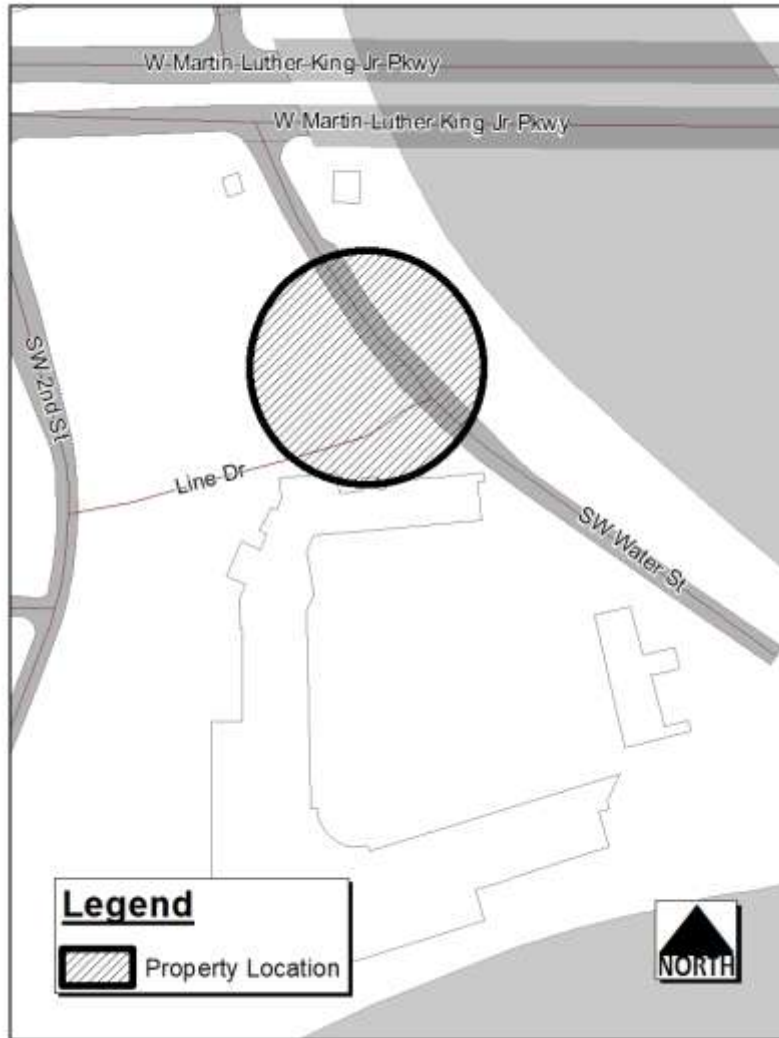

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Principal Park Cub Club Parking Lot Improvements, 11-2016-009. The improvement includes construction of sidewalks, parking lot modifications with Hot Mix Asphalt (HMA) and Portland Cement Concrete (PCC), pavement markings, parking signage, site restoration, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 574-140/151, at Principal Park, 1 Line Drive, Des Moines, Iowa.

The estimated construction cost is \$100,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
