AGENDA HEADING:

Approving Professional Services Agreement with Stantec Consulting Services, Inc. for design phase services for SE 9th Street Stormwater Pump Station, not to exceed \$379,000.

SYNOPSIS:

Recommend approval of the Professional Services Agreement with Stantec Consulting Services, Inc., Bob Welsch, Principal, 1859 Bowles Avenue, Suite 250, Fenton, MO 63026, for a total cost not to exceed \$379,000, based on hourly rates, to provide Design Services for the SE 9th Street Stormwater Pump Station.

FISCAL IMPACT:

Amount: \$379,000

Funding Source: 2016-17 Capital Improvement Program (CIP), Page Storm Water- 6, Flood Mitigation Improvements, SM087.

ADDITIONAL INFORMATION:

On June 24, 2013, by Roll Call No. 13-1059, City Council approved a professional services agreement with Stantec Consulting Services, Inc. for an assessment and analysis of the Des Moines Downtown Levee Systems relative to Federal Emergency Management Agency accreditation requirements. This included identifying a plan of projects to both reduce flood risk within the levee areas and bring the levee system into compliance with the FEMA accreditation requirements. One (1) component of the plan identified the necessary improvements to the interior drainage pump stations along the DM-I, DM-II, and DM-III levee systems, required to meet FEMA criteria. This professional services agreement provides for the design of a new stormwater pump station to replace the existing SE 9th Street pump station.

A Request for Proposals (RFP) for the design and construction phase services on the SE 9th Street Stormwater Pump Station was issued, posted on the City’s website, and printed in the newspaper. A selection committee of City Public Works, Deputy City Engineer, and Engineering staff, reviewed and rated the five (5) proposals received in response to the RFP. Stantec Consulting Services, Inc. was selected to design the SE 9th Street Stormwater Pump Station.

Staff has negotiated a Professional Services Agreement with Stantec Consulting Services, Inc., for a total cost not to exceed \$379,000, based on hourly rates, to provide design services.
