# AGENDA HEADING:

Accept and approve the procurement of various rip rap products from Martin Marietta for good cause shown pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines at a total cost of \$158,224.50.

### SYNOPSIS:

The City Manager has determined that good cause has been shown to forego procedures for procurement of various rip rap products from Martin Marietta Aggregates for use by the Public Works Department in the 2016 Stream Bank Stabilization project. Of the three (3) vendors contacted for pricing, Martin Marietta, is the only available source for the products for use in stream bank stabilization at Four Mile and Walnut Creeks. Work on both projects may proceed this fall if Council approves the purchase. City Council action is recommended.

# FISCAL IMPACT:

<u>Amount</u>: \$158,224.50. Waiver requested for \$14,695, \$143,529.50 currently under contract V15-089.

<u>Funding Source</u>: FY2016-2017 Capital Improvements Program, E304PW99 SM134, Levee Improvements

# **ADDITIONAL INFORMATION:**

- The Engineering Department has entered into a Professional Services Agreement with River Research and Design (Dave Derrick, Vice President) for construction and design services for the 2016 Stream Bank Restoration project. Mr. Derrick aided in the design of stream bank stabilization projects at three (3) locations along Walnut Creek and Four Mile Creek where bank erosion is impacting public trail and levee infrastructure.
- Public Works and Parks and Recreation staff will be installing the bank stabilization measures this fall, and Mr. Derrick will be assisting City crews to ensure functional operation of the stream bank stabilization infrastructure.
- The stream bank construction will required Class D rip rap, Class B rip rap and a very specific crusher run material that binds the larger rip rap materials together. The Class D rip rap is currently covered under a City Contract (Contract V15-089), the other materials are not on the contract. Total price for all materials needed to complete both phases of the stream bank stabilization project is \$158,224.50.

• This waiver is being requested after checking with two (2) other vendors, Schildberg Construction and Hallett Materials. Neither company have these materials on hand, and have ceased production of them for the remainder of 2016. Martin Marietta Aggregates has confirmed they are still producing materials, and have ample product available at this time.
