AGENDA HEADING:

Resolution acknowledging assignment of Urban Renewal Development Agreement and Economic Development Grant payments for the Liberty Building Rehabilitation and Parking Garage Development.

SYNOPSIS:

Liberty Building Historic Rehab, L.L.C. and 418 Hospitality, L.L.C., B.J. Baker, Manager for both entities, desire to sell their interests in the Liberty Building and the Hyatt Place Hotel, 418 6th Avenue, to Liberty Des Moines, L.L.C. a new entity owned and managed by the Schulte Hospitality Group, Ray Schulte, COO, 2000 High Wickham Place, Suite 300, Louisville, Kentucky. Under the Assignment and Assumption Agreement, all Developer interests and responsibilities under the Metro Center Urban Renewal Development Agreement and all future installment of the economic development grant installments will be assigned to and assumed by Liberty Des Moines, L.L.C., who has requested the City's acknowledgment and consent to the document.

The terms and conditions of the Development Agreement and responsibilities of the Developer and City are not affected by the Assignment and Assumption Agreement. City Legal and Office of Economic Development staff have reviewed the Assignment and Assumption Agreement and recommend approval.
