**AGENDA HEADING:**

Ordering construction of the following: 30th Street and Jefferson Avenue Culvert Replacement at Closes Creek - Receiving bids, (9-27-16), and Setting date of hearing, (10-10-16). Construction Estimate - \$610,000.

**SYNOPSIS:**

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. Replacement of 66-inch brick culvert with a six (6) foot by 12 foot concrete box culvert and an extension of 36-inch storm sewer to provide improvements identified in the Closes Creek drainage study.

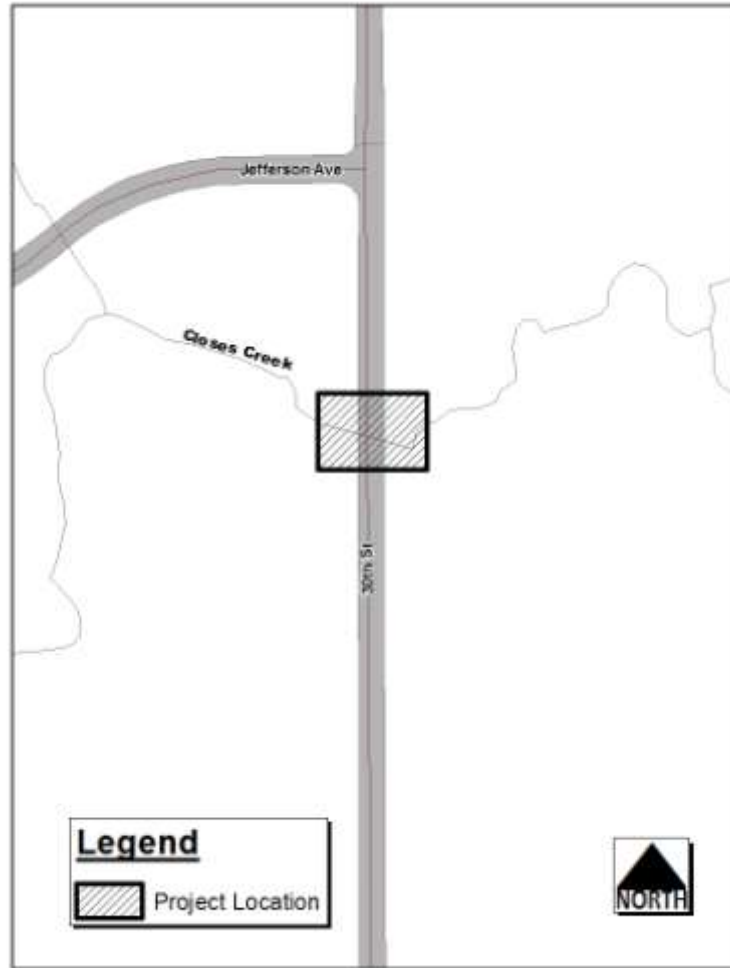

**ADDITIONAL INFORMATION:**

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 30<sup>th</sup> Street and Jefferson Avenue Culvert Replacement at Closes Creek, 08-2016-004. The improvement includes the abandonment of a 66-inch brick storm culvert on 30<sup>th</sup> Street and the construction of a six (6) foot high, 12 foot wide reinforced concrete box culvert, a 36-inch arch reinforced concrete pipe, intakes, Portland Cement Concrete (PCC) curb and gutter, Hot Mix Asphalt (HMA) pavement replacement, clearing, traffic control, tree protection, erosion control items, other incidental items; all in accordance with the contract documents including Plan File Nos. 574-152/173, located along 30<sup>th</sup> Street at Closes Creek, Des Moines, Iowa.

The estimated construction cost is \$610,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
