#### **AGENDA HEADING:**

Approving Change Order No. 4 with Rochon Corporation of Iowa for additional contract time and work on the Pioneer Columbus Community Center Remodeling project for the amount of \$43,398.

#### **SYNOPSIS:**

Recommend approval of request from Rochon Corporation of Iowa, Inc. (Ron Rochon, President, 3401 106<sup>th</sup> Circle, Urbandale, Iowa, 50322) for additional work and extension of time to the contract on the Pioneer Columbus Community Center Remodeling project.

#### **FISCAL IMPACT:**

Amount: \$43,398

Funding Source: 2016-2017 Capital Improvement Program (CIP), Page Park - 5, Community Center

Improvements, PK033, G.O. Bonds

#### ADDITIONAL INFORMATION:

- The original completion provision for the Pioneer Columbus Community Center Remodeling project was September, 1, 2016. Due to the installations of a new underground grease trap interceptor and planned building wide automatic fire suppression sprinkler system, the building's existing water and sanitary services water required additional work beyond what was originally identified in the contract documents.
- Change Order No. 4 in the amount of \$43,398 has been negotiated with Rochon Corporation of Iowa to address the required water and sanitary services upgrades in order to bring the facility into compliance with current building code standards.
- Staff recommends approving an extension to May 31, 2017 to provide the contractor the option to complete additional subsurface site utility work during the spring of 2017 as well as meet the recommended spring planting dates of April 1 through June 30 as required by the current SUDAS Standard Specifications for specified landscaping work.
