### **AGENDA HEADING:**

Hearing on Glendale Cemetery Abbey Heating, Ventilation, and Air Conditioning (HVAC) and electrical upgrades: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Central Iowa Mechanical Company, Larry D. ### SYNOPSIS:


On October 10, 2016, under Roll Call No. 16-1691, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Glendale Cemetery Abbey HVAC and electrical upgrades. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Glendale Cemetery Abbey HVAC and electrical upgrades, 11-2016-014. The improvement includes construction of a HVAC system, new 480 volt electrical service, interior electrical repair, concrete patching, and removal of exhaust roof vents; all in accordance with the contract documents, including Plan File Nos. 573-095/115, located at the Glendale Cemetery, 4909 University Avenue, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Central Iowa Mechanical Company, Larry D. Goode, Jr., President, 204 S.W. 2<sup>nd</sup> Street, Des Moines, IA, 50309 in the amount of \$189,380, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
