# AGENDA HEADING:

Receive and file report from Vital Neighborhoods Consulting, LLC regarding Strategies to Address and Prevent Vacant and Blighted Properties, and refer to the City Manager for staff review and response.

### SYNOPSIS:

The City contracted with Vital Neighborhoods Consulting, LLC to prepare a report recommending strategies for addressing vacant and blighted properties, and preventing the issue more effectively in the future. The report contains a number of recommendations related to code enforcement practices, revisions to the housing code, data collection, and land banking.

### FISCAL IMPACT: NONE

#### **ADDITIONAL INFORMATION:**

- Vacant, abandoned, and blighted properties are a serious issue that threaten the health of many of Des Moines' neighborhoods. Taking a more proactive and coordinated approach to addressing this issue has been recommended by the Capital Crossroads Neighborhood Improvement Plan, PlanDSM, and GuideDSM.
- On July 11, 2016, City Council approved a professional services agreement with Vital Neighborhoods Consulting, LLC to provide technical assistance on how to more effectively address vacant and blighted properties on a Citywide scale as well as through targeted neighborhood revitalization efforts.
- The Consultant met with City and County staff, City Council members, and other community stakeholders during a site visit July 19-21, 2016. Since that time, the Consultant has been working with City staff from the Community Development and Legal departments to develop the set of recommendations contained in this report.
- The report recommends a number of strategies for how the City should respond to properties that are already nuisances in order to return them quickly to productive use, as well as mechanisms the City should put into place in order to prevent properties from becoming dilapidated. The majority of the report focuses on code enforcement tools for residential

property, although there are also recommendations regarding data collection to inform decision-making, and land banking as a tool for addressing this issue in the context of neighborhood revitalization.

• While City staff has been involved in the development of this report, staff will need to assess the resource implications of the recommendations and will return to Council at a later date with an implementation plan.
