AGENDA HEADING:

Ordering construction of the following: Park Avenue Elementary Pedestrian Bridge Removal and Site Improvements - Receiving bids, (2-7-17), and Setting date of hearing, (2-20-17). Construction Estimate - \$522,000.

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. The project includes the removal of a pedestrian bridge over S.W. 9th Street near Park Avenue, the removal of the southbound right-turn lane on S.W. 9th Street, and construction of parking insets along Park Avenue and S.W. 7th Street, adjacent to Park Avenue Elementary School.

FISCAL IMPACT:


Amount: \$522,000 (City Engineer's Estimate)

<u>Funding Source</u>: 2016-2017 CIP, Page Bridge – 4, City-wide Bridges, BR003, G. O. Bonds, being: \$184,778.90 in G.O. Bonds, BR003; \$7,500.00 from Des Moines Water Works; and the remaining \$329,721.10 from the Des Moines Public School District.

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Park Avenue Elementary Pedestrian Bridge Removal and Site Improvements, 04-2017-002. The improvement includes the removal of a pedestrian bridge over S.W. 9th Street near Park Avenue and the southbound right-turn lane on S.W. 9th Street, construction of Portland Concrete Cement (PCC) on-street parking insets, curb and gutter, sidewalks and curb ramps, segmental block retaining walls, fencing, and concrete steps, together with the necessary removals, earthwork, clearing and grubbing, erosion control, storm sewers, traffic control and incidental items; all in accordance with the contract documents, including Plan File Nos. 578-063/117, along S.W. 9th Street, Park Avenue, and S.W. 7th Street near Park Avenue Elementary School, Des Moines, Iowa.

The estimated construction cost is \$522,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
