Carrie Kruse (NR-2), Economic Development Coordinator, to Minneapolis, MN from June 4 –June 9, 2017 (\$2,709.88) to attend the Economic Development Finance course offered through the National Development Council. This rigorous and comprehensive training series is designed solely for economic development practitioners and will help learn the tools and techniques of the trade to build the capacity needed to successfully translate economic development opportunities into results for the City of Des Moines.

Darrell Caldwell, (R-1), Sanitation Administrator, to Los Angeles, CA from January 22 – January 27, 2017 (\$2,791.35) to attend the US Composting Council 25th Annual Conference. This will allow the City of Des Moines to have a representative at the conference for the first time. The conference promotes peer to peer exchange on common problems and solutions, providing sound strategies and effective tools to address the City's issues in an innovative way with opportunities for networking and establishing rapport.

The original budget for travel and training in Fiscal Year (FY) 2017 is \$524,665. The amount expended for travel and training in FY 2017, as of January 17, 2017, is \$226,114.29.
