AGENDA HEADING:

Ordering construction of the following: 2017 Municipal Buildings Reroofing - Contract 1 - Receiving bids, (2-21-17), and Setting date of hearing, (3-6-17). Construction Estimate - \$330,000.

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the replacement of two (2) municipal building roofs that have deteriorated resulting in leaks throughout the buildings.



<u>Funding Source</u>: 2016-2017 CIP, Page Building – 9, Municipal Building Reroofing, BL044, Being: \$105,000 in G.O. Bonds, BL044, with a transfer of \$225,000 from PG016.

ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2017 Municipal Buildings Reroofing Contract 1, 10-2017-002. The improvement includes the complete removal of the existing roofing materials and installation of a fully adhered white Thermoplastic Polyolefin (TPO) roof on two (2) municipal buildings; all work in accordance with the contract documents including Plan File Nos. 578-037/040, located at the 5th & Keo Parking Garage (525 5th Avenue), and the IMPACT Administrative Office (3226 University Avenue), all in Des Moines, Iowa.
- The estimated construction cost is \$330,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
