ADDITIONAL INFORMATION:

- On August 22, 2016, by Roll Call No. 16-1386, Stantec Consulting Services, Inc. was hired to provide professional engineering services for the SE 9th Street Storm Water Pump Station.
- Supplemental Agreement No. 1 to the Professional Services Agreement with Stantec Consulting Services, Inc. provides for additional hydrologic and hydraulic modeling to:
 - Reflect the existing depressed sewer sections found on SE 9th Street during the field survey, consideration of removing the depressed sewer at Railroad Avenue, and the existing conditions of the 78-inch storm sewer on SE 9th Street.
 - Reflect leaving in place three (3) segments of storm sewer along Maury Street (instead of replacing the segments).
 - Consider 200 cubic feet per second or larger pump sizes and an above ground storage basin option.
- Staff recommends approval of Supplemental Agreement No. 1 for professional services with Stantec Consulting Services, Inc.
