Benjamin Campbell (NR-0), Senior Crime Scene Investigator, to Denver, CO, from May 15 – May 18, 2017 (\$1,551.40) to attend a course titled "Courtroom Testimony Techniques – Success Instead of Survival". Part of the duties as a crime scene investigator is to testify in trials, this course will aid in preventing errors in the courtroom.

Brady Carney (NR-0), Vice Narcotics Investigator, to San Antonio, TX, from March 21 – March 25, 2017 (\$1,837.36) to attend the Mexican Cartels and Gangs Seminar. Mexican drug cartels and drug trafficking organizations are present in the Des Moines area and this training is necessary and extremely beneficial and will also allow networking with other narcotics investigators around the country to stay up-to-date in these evolving issues.

Lisa Crabbs (R-1), Assistant Planner, to Denver, CO from March 26 –March 30, 2017 (\$1,495) to attend CDBG training which will help better understand federal rules and regulations that apply to this federal funding allowing for compliance with rules and continued funding.

Ryan Moffatt, (R-0), Economic Development Project Manager, to Blue Springs, MO from April 23 – April 27, 2017 (\$1,869.42) to attend the Heartland Economic Development Course. This is in-depth training on economic development concepts such as workforce development, business attraction and retention, and neighborhood and community reinvestment. A grant has been applied for that would cover the registration cost of \$985.
