#### **AGENDA HEADING:**

Subdivision Improvement Bond Release for Carman Estates Plat 4.

#### **SYNOPSIS:**

Recommend a release of the remaining surety amount of \$10,698 of the original subdivision improvement bond, having an original amount of \$42,791, for Carman Estates Plat 4 subdivision since completion of the required sidewalks and recreation trails has been completed to the satisfaction of the Engineering Department.

## FISCAL IMPACT: NONE

#### ADDITIONAL INFORMATION:

- On January 23, 2006, the City Council approved and accepted the original bond for infrastructure improvements for \$42,791 for the Carman Estates Plat 4 subdivision. On January 27, 2014, the developer requested a reduction in the required surety, since much of the subdivision improvement work was completed, for \$32,093.
- The installation of 161 linear feet of 4-foot wide sidewalk, and 69 linear feet of recreational trail was completed. On January 5, 2017 the site was inspected by Engineering Department staff and it was determined that Bond No. IAC 35800 from Merchants Bonding Company, with a remaining surety for \$10,698 could now be released based upon satisfactory completion.
- Carman Estates Plat 4 is located near SE 24<sup>th</sup> Street and E. Porter Avenue and consists of 42 single-family home lots on 11.9-acres. This plat is now complete.
