AGENDA HEADING:

Set date of public hearing on the proposed 1st Amendment to the Urban Renewal Plan for the Northeast Gateway 1 Urban Renewal Area.

SYNOPSIS:

Set the date of public hearing on the proposed 1st Amendment to the Urban Renewal Plan for the Northeast Gateway 1 Urban Renewal Area for the May 22, 2017 City Council meeting and authorizes the required consultation meeting with representatives from Polk County, Saydel Community School District, Des Moines Area Community College and Des Moines Area Regional Transit on May 3, 2017.

 provides a summary of projects proposed to receive tax increment revenues from the
 Northeast Gateway 1 Urban Renewal Area. This Amendment adds the Thompson
 Properties L.C. (d/b/a Heating and Cooling Supply Company, Inc.) development
 agreement as a project.

- (D) <u>Resolution</u> closing the hearing on the Northeast Gateway 1 Urban Renewal Plan and adopting same. Moved by Westergaard to adopt. Motion Carried 7-0.
- (E) <u>First</u> consideration of ordinance authorizing the use of Tax Increment Financing (TIF) within the Northeast Gateway 1 Urban Renewal Area. Moved by Westergaard that this ordinance be considered and given first vote for passage. Motion Carried 7-0.
 - (1) Final consideration of ordinance above, requires six votes. Moved by Westergaard that the rule requiring that an ordinance must be considered and voted on for passage at two Council meetings prior to the meeting at which it is to be finally passed be suspended, that the ordinance be placed upon its final passage and that the ordinance do now pass, #15,568. Motion Carried 7-0.
