# AGENDA HEADING:

Ordering construction of the following: 2017 PCC Paving and Sidewalk Program - Receiving bids, (5-9-17), and Setting date of hearing, (5-22-17). Construction Estimate - \$267,000.

### SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project includes Portland Cement Concrete (PCC) pavement reconstruction and sidewalk connectivity improvements at multiple locations in Des Moines. This project also includes the construction of a plaza in Ewing Park to be used as a viewing area and venue for small events.



### **ADDITIONAL INFORMATION:**

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2017 PCC Paving and Sidewalk Program, 06-2017-012. The improvement includes pavement removal, subgrade preparation, modified subbase, perforated subdrain, PCC pavement, curb and gutter, sidewalk and shared use path, pavement markings, surface restoration, traffic signal repairs, together with other incidental items; all in accordance with the contract documents, including Plan File Nos. 579-153/219, at the following locations in the City of Des Moines, Iowa:

Ewing Park 30<sup>th</sup> Street between Carpenter Avenue and Forest Avenue Neil Smith Trail near 6<sup>th</sup> Avenue and Birdland Drive 43<sup>rd</sup> Street and Chamberlain Drive E. 42<sup>nd</sup> Street from Thompson Avenue to Easton Boulevard. The estimated construction cost is \$267,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
