# AGENDA HEADING:

Hearing on Glendale Cemetery Road Reconstruction: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Jeffrey A. Chapman, General Manager, \$315,450.

## SYNOPSIS:

This is a public hearing to allow for public input on the Glendale Cemetery Road Reconstruction and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for reconstruction of selected roads in Glendale Cemetery. This reconstruction includes localized curb and gutter repair, subgrade treatment, and full depth Hot Mix Asphalt (HMA) paving. This project addresses deteriorated road conditions in Glendale Cemetery.


# **ADDITIONAL INFORMATION:**

On March 20, 2017, under Roll Call No. 17-0459, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Glendale Cemetery Road Reconstruction. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Glendale Cemetery Road Reconstruction, 11-2017-005. The improvement includes reconstruction of Glendale Cemetery roads including pavement removal, manhole adjustments, subgrade treatment, Portland Concrete Cement (PCC) curb and gutter, and HMA paving; all in accordance with the contract documents including Plan File Nos. 579-042/054 at Glendale Cemetery, 4909 University Avenue, Des Moines, Iowa.

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Jeffrey A. Chapman, General Manager, 2401 SE Tones Drive, Ste. 13, Ankeny, IA, 50021 in the amount of \$315,450, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
