AGENDA HEADING:

Petition to amend and merge the two (2) existing Sherman Hill Self-Supported Municipal Improvement Districts (SSMID) into a single district.

SYNOPSIS:

Staff recommends that the City Council receive, file and refer the petition to the City Plan & Zoning Commission for preparation of an evaluative report on the merit and feasibility of establishing the Sherman Hill SSMID and Operation Fund. The City Council will receive the evaluative report at the June 12, 2017 regular City Council meeting.

FISCAL IMPACT:

<u>Amount</u>: The petition specifies a tax levy rate not to exceed \$3.50 per \$1,000 dollars of taxable valuation. The two (2) existing SSMID accounts will be merged and managed as one (1) account going forward.

ADDITIONAL INFORMATION:

- The City Clerk has received a petition to amend and merge the two (2) existing Sherman Hill Self-Supported Municipal Improvement Districts (SSMID) into a single district.
- Pursuant to Iowa Code Section 386.3(3), "the City Council shall notify the City planning commission upon receipt of a petition. It shall be the duty of the City planning commission to make recommendations to the council in regard to the proposed district. The City planning commission shall, with due diligence, prepare an evaluative report for the council on the merit and feasibility of the project. The Council shall not hold its public hearings or take further action on the establishment of the district until it has received the report of the City planning commission. In addition to its report the commission may, from time to time, recommend to the council amendments and changes relating to the project."
- Staff has placed the proposed establishment of the Sherman Hill SSMID on the agenda for the June 1, 2017 Plan and Zoning Commission meeting. Staff anticipates they will forward to the City Council for the June 12, 2017 regular meeting the evaluative report and recommendations of the Plan and Zoning Commission.
