# AGENDA HEADING:

Hearing on 2017 PCC Paving and Sidewalk Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Cerebral Group, LLC, Kalyan Venkatraman, President, \$263,441.70.

### **SYNOPSIS:**

This is a public hearing to allow for public input on the 2017 PCC Paving and Sidewalk Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project includes Portland Cement Concrete (PCC) pavement reconstruction and sidewalk connectivity improvements at multiple locations in Des Moines. This project also includes the construction of a plaza in Ewing Park, funded by Friends of Des Moines Parks, to be used as a viewing area and venue for small events.



Bonds; \$39,716.00 in G.O. Bonds transferred from PK137; \$55,508.80 in G.O. Bonds transferred from PK045; and the remaining \$60,261.40 in G.O. Bonds transferred from SW081.

## **ADDITIONAL INFORMATION:**

On April 17, 2017, under Roll Call No. 17-0649, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2017 PCC Paving and Sidewalk Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2017 PCC Paving and Sidewalk Program, 06-2017-012. The improvement includes pavement removal, subgrade preparation, modified subbase, perforated subdrain, Portland Cement Concrete (PCC) pavement, curb and gutter, sidewalk and shared use path, pavement markings, surface restoration, traffic signal repairs, together with other incidental items; all in accordance with the contract documents, including Plan File Nos. 579-153/219, at the following locations in the City of Des Moines, Iowa:

- Ewing Park
  - 30th Street between Carpenter Avenue and Forest AvenueNeal Smith Trail near 6th Avenue and Birdland Drive43rd Street and Chamberlain DriveE. 42nd Street from Thompson Avenue to Easton Boulevard.
- Sealed bids for said improvement were submitted by the following bidders: TK Concrete Inc., Pella, IA Cerebral Group, LLC, Des Moines, IA MPS Engineers, P.C. dba Kingston Services, P.C., Des Moines, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the Shijiazhuang Room, 2nd Floor, City Administration Building, 400 E. Court Avenue, Des Moines, Iowa at 11:00 a.m. on May 9, 2017.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Cerebral Group, LLC, Kalyan Venkatraman, President, 1540 High Street, Suite 102, Des Moines, IA, 50309 in the amount of \$263,441.70, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
