#### **AGENDA HEADING:**

Resolution setting date of public hearing on the proposed 2nd Amendment to the Urban Renewal Plan for the Ingersoll-Grand Commercial Urban Renewal Area.

#### **SYNOPSIS:**

This roll call sets the date of public hearing on the proposed 2nd Amendment to the Ingersoll-Grand Commercial Urban Renewal Plan for the July 24, 2017 City Council meeting and authorizes the required consultation meeting with representatives from Polk County, Des Moines Public Schools, Des Moines Area Community College and Des Moines Area Regional Transit in the interim. The amendment updates the urban renewal plan with information as required by state law relating to the provision of tax increment financial (TIF) assistance for private and public projects that have been and may be approved by the City Council, and an updated financial condition report.

### FISCAL IMPACT: NONE

<u>Amount</u>: There is no direct fiscal impact associated with the approval of the 2nd Amendment. The activities and projects that may be assisted by this urban renewal plan and tax increment revenues are now listed in the plan text and are subject to separate Council action.

### ADDITIONAL INFORMATION:

• The Amendment, as required by state law, provides an update on projects that are anticipated to use tax increment financing. The urban renewal plan now identifies the Ingersoll-Grand Streetscape – Martin Luther King Junior Parkway to 28th Street project, consisting of preliminary conceptual design, construction phasing plans, and cost estimates, for the construction of the Ingersoll Avenue Streetscape from Martin Luther King Junior Parkway to 28th Street, as an approved urban renewal project eligible for financial assistance funded in part from the tax increment revenues generated by the Ingersoll-Grand Commercial Urban Renewal Area.
