AGENDA HEADING:

Hearing for conveyance of an easement for overhead and underground electric lines located within Waveland Golf Course to MidAmerican Energy Company (MEC) for \$2,220.

SYNOPSIS:

Recommend approval of an easement for overhead and underground electric lines located within Waveland Golf Course to MidAmerican Energy Company (MEC), P.O. Box 657, Des Moines, Iowa 50306 for \$2,220. This action is required by Iowa law prior to making a final determination on the proposed easement conveyance by resolution.



ADDITIONAL INFORMATION:

- On August 19, 2011, by Roll Call No. 11-1497, the City Council approved the sale of a portion of Waveland Golf Course property to Russell D. and Marilyn A. Parks in exchange for a comparable parcel of land adjoining Cumming Woods for a townhome development project. The townhome development project requires relocation of existing overhead electric transmission lines onto the adjoining golf course property.
- MEC has requested an easement on the City's adjoining golf course property for relocation of the electric lines in order to accommodate the townhome development. MEC has offered to the City the purchase price of \$2,220 for the purchase of a permanent easement for overhead and underground electric lines. The easement area is 10-feet wide and consists of approximately 3,551 square feet, and the purchase price is equal to the fair market value as determined by the City's Real Estate Division.
- City Park and Recreation and Forestry staff have reviewed the electric line relocation plan and have determined that the City and the public will not be inconvenienced by the conveyance of the permanent easement.
