#### **AGENDA HEADING:**

Approval of the purchase of eight (8) Hewlett-Packard (HP) servers from OneNeck IT Solutions per State of Iowa contract pricing agreement for use with the upcoming Computer Aided Dispatch (CAD) software update.

#### **SYNOPSIS:**

Recommend approval of the purchase of eight (8) separate servers from OneNeck IT Solutions (11191 Aurora Avenue, Urbandale, IA 50323) per the State of Iowa pricing agreement (HPE Contract #16091-B). The HP servers will be used to store and share data for the CAD system which allows for police dispatchers to give pertinent geographical information to police officers. The CAD system serves as one (1) of the most integral pieces of police operations.

### **FISCAL IMPACT:**

Amount: \$70,172.06

Funding Source: FY 2018 Recommended Operating Budget, E911 Reimbursement, page 195.

### **ADDITIONAL INFORMATION:**

- Council action on June 12, 2017 authorized an upgrade of the Intergraph CAD system from Version 9.2 to 9.4. The largest driver of the upgrade is to remain current with the CAD product. This new version will facilitate improved service delivery to the officers and firefighters on the street. With the additional functionality of this new version, it will allow for interfacing to other software products more easily.
- The upgrade is scheduled to begin in September 2017 and go into production in April 2018.
- The eight (8) new servers include two (2) production database servers, one (1) database archive server, two (2) communication servers, and three (3) additional servers for applications specific to Integraph.
- As part of that upgrade the six (6) existing servers are needed to be replaced, along with two (2) new servers needed for new applications. The existing servers, which are no longer under warranty, will be repurposed within the Police Department for less mission critical operations.
