AGENDA HEADING:

Recommend approval for the purchase of 40 body-worn cameras, software licenses, and warranties from Watchguard Video, 415 Century Parkway, Allen, TX 75013 (Stephan Coffman, President).

SYNOPSIS:

Recommend approval for the Police Department to purchase 40 body-worn cameras and corresponding software licenses and warranties to add to the current inventory of 300 body-worn cameras. As the department moves closer to authorized strength, this purchase will ensure that all upcoming officer recruits will be issued a new camera. It will also increase availability of cameras while broken or damaged cameras are being replaced and will ensure that officers working in an off-duty capacity will have access to a camera.

FISCAL IMPACT:

Amount: \$63,400

ADDITIONAL INFORMATION:

- Des Moines Police Department conducted a Request for Proposals (RFP) for an in-car and body-worn camera solution in December 2015 and ultimately selected Watchguard as the preferred vendor in September 2016.
- The City ordered on contract and implemented 300 body-worn cameras throughout the Police Department during 2016 and 2017.
- This order of body-worn cameras is the exact same model and software version as the initial contract purchase.
- All cameras have a 3-year no-fault warranty. The department has replaced 72 body cameras at no additional cost to the City.
