## **AGENDA HEADING:**



### **ADDITIONAL INFORMATION:**

- This project provides environmental and geotechnical services for the design and construction of the MSC- Phase 2 project, for the property bordered by Scott Avenue, S.E. 18<sup>th</sup> Street, Maury Street, and the alley between S.E. 15<sup>th</sup> Court and S.E. Astor Street. This Professional Services Agreement provides for the environmental investigation of recognized environmental conditions in the soil and groundwater. The geotechnical study will evaluate physical characteristics of subsurface conditions with respect to design and construction of the project.
- A Request for Proposals (RFP) for environmental and geotechnical services for the MSC—Phase 2 project was issued, posted on the City's website, and printed in the newspaper. A selection committee of Engineering staff reviewed and rated the four (4) proposals received in response to the RFP. Terracon Consultants, Inc. was selected to perform environmental and geotechnical services for the MSC—Phase 2 project.
- Staff has negotiated a Professional Services Agreement with Terracon Consultants, Inc. for a total cost not to exceed \$30,450, based on hourly rates, to provide environmental and geotechnical services.
