AGENDA HEADING:

Hearing on 63rd Street and Creston Avenue Traffic Signals: Resolution approving plans, specifications, form of contract documents, engineer’s estimate, receive and file bids, and designating lowest responsible bidder as Iowa Signal Inc., Wayne Lesley, President, \$155,911.20.

SYNOPSIS:

This is a public hearing to allow for public input on the 63rd Street and Creston Avenue Traffic Signals and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes new traffic signals at the intersection of 63rd Street (IA 28) and Creston Avenue, interconnecting the new signal with the existing signal at 63rd Street and Park Avenue to allow coordination between the two (2) signals, and the addition of a new westbound left-turn lane on Creston Avenue.

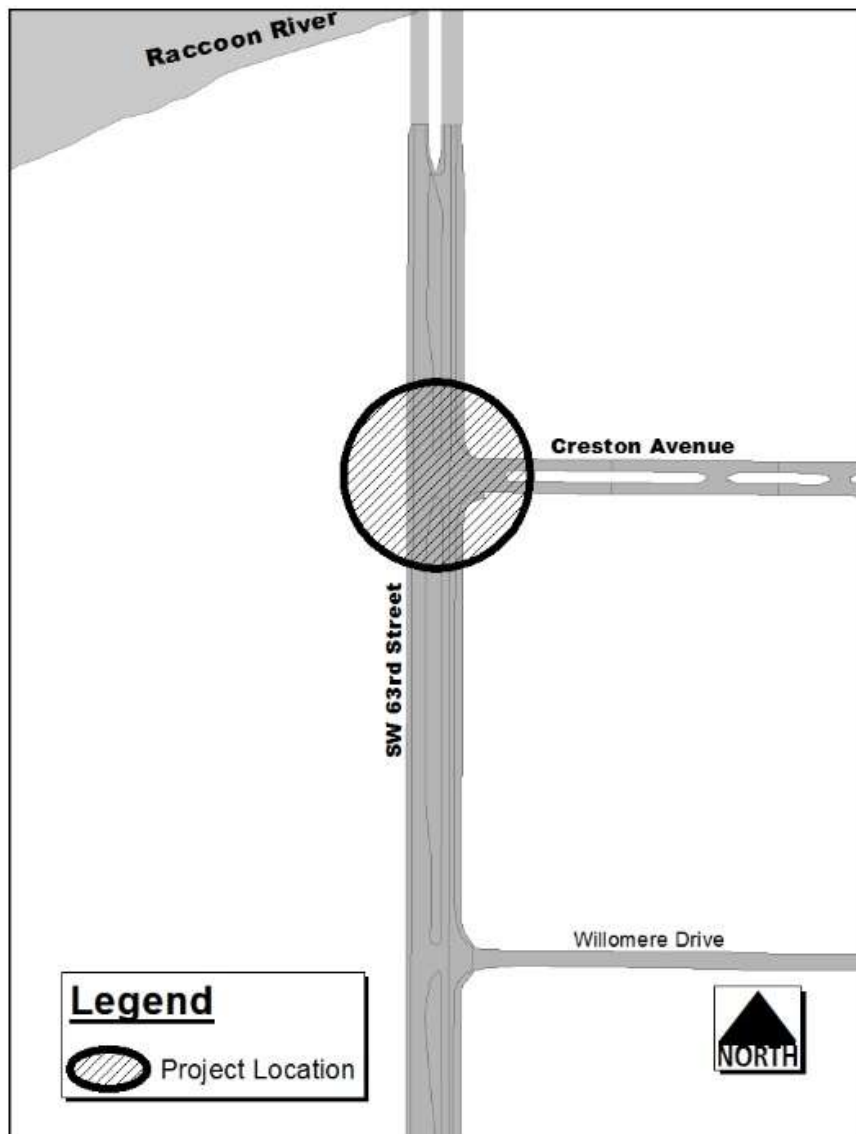
Amount: \$155,911.20 Construction Contract (\$215,000 City Engineer's Estimate)

Funding Source: 2017-2018 CIP, Page Streets – 44, Traffic Signals, Channelization, and School Crossings, TR091, Being: \$85,751.16 in Iowa DOT Urban State Traffic Engineering Program (USTEP) Funds (55% of eligible items with a max of \$200,000) under agreement UST-028-2(47)--4A-77; and the remaining local 45% matching funds of \$70,160.04 in G.O. Bonds.

ADDITIONAL INFORMATION:

- On July 10, 2017, under Roll Call No. 17-1139, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 63rd Street and Creston Avenue Traffic Signals. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 63rd Street and Creston Avenue Traffic Signals, 04-2017-004. The improvement includes new traffic signals, vehicle loop detectors, 10" Portland Cement Concrete (PCC) pavement, PCC sidewalk, pavement markings, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 585-040/056, located at the intersection of 63rd Street (IA 28) and Creston Avenue, Des Moines, Iowa.

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Iowa Signal Inc., Wayne Lesley, President, 3711 SE Capitol Circle, Grimes, IA, 50111 in the amount of \$155,911.20, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
