- The current owner of River Hills Apartments #1, located at 700 E. 5<sup>th</sup> Street, Des Moines, Iowa, has opted out of their Section 8 HUD Multifamily Housing Program contract and Section 8 Housing Choice vouchers are being requested for an additional 11 eligible residents at River Hills Apartments #1.
- DMMHA will be awarded 11 Housing Choice vouchers to provide rental assistance to these families.
- The annual funding amount for rental assistance will be approximately \$55,312.
