AGENDA HEADING:

Approving and authorizing execution of a Contract (Cooperative Agreement) with the Iowa Civil Rights Commission.

SYNOPSIS:

This agreement provides for partial reimbursement for Des Moines Civil & Human Rights Commission investigative work paid by the State through the Iowa Civil Rights Commission. The agreement covers the fiscal year (FY) beginning July 1, 2017 and ending June 30, 2018.

Action: Cooperative Agreement: Barr described the relationship between the department and Iowa Civil Rights Commission. Cooperative agreement requires the Commission chair to sign off in order for the department to get paid for complaints processed through the department to ICRC. Barr stated that the agreement brought in an additional \$8,000 to the department. Knox asked about follow up from a previous conversation to partner with EEOC. Barr stated at the time of the conversation, there was no staff, but are inching towards initiating discussions about a workshare agreement with the EEOC within six (6) months. Middlebrook moved. Shields seconded. Pass. 6-0.
