AGENDA HEADING:

Approval of grant agreements with the U.S. Department of Housing and Urban Development (HUD) for funding of the City’s Third Year (2017) Action Plan of the 2015-2019 HUD Consolidated Plan.

SYNOPSIS:

Recommend Council approval of grant agreements by and between HUD and the City of Des Moines, whereby the City will receive Community Development Block Grant (CDBG), HOME Investment Partnership program (HOME), and Emergency Solutions Grant (ESG) funding (grant awards) for the implementation of the Third Year (period of January 1, 2017 to December 31, 2017) Action Plan of the 2015 - 2019 HUD Consolidated Plan.

FISCAL IMPACT:

Amount: \$4,442,067

Funding Source: FY 2017-2018 Operating Budget, Community Development: Special Revenue Funds, Community Development Block Grant Fund, Page 57; HOME Fund, Page 57; Homeless Fund, Page 57.

ADDITIONAL INFORMATION:

- At the City Council meeting on February 6, 2017, the Council approved the Third (2017) Year Action Plan of the 2015-2019 HUD Consolidated Plan consisting of CDBG, HOME, and ESG funding. From 2016 to 2017, funding for CDBG has increased by \$20,940, funding for HOME has decreased by \$19,902, and funding for ESG decreased by \$4,618. The Grant Agreements must be processed in order to receive the City’s entitlement funding for these programs.
