AGENDA HEADING:

Hearing on Principal Park Batting Tunnel Building Expansion: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Septagon Construction Company, Inc., Brad Leonard, President, \$463,140.

SYNOPSIS:

This is a public hearing to allow for public input on the Principal Park Batting Tunnel Building Expansion and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The Principal Park existing batting tunnel was constructed in 1995, is undersized, and needs to be enlarged to be consistent with similar sized baseball programs. The proposed improvement will enlarge the batting tunnel to address these concerns.


<u>Amount</u>: \$463,140 Construction Contract (\$400,000 City Engineer's Estimate)

<u>Funding Source</u>: 2017-2018 CIP, Page Parks – 12, Principal Park, PK132, Being: \$294,450 in G.O. Bonds, and the remaining \$168,690 from the Iowa Cubs to be paid in \$25,000 installments every six (6) months – (the first payment which has been received).

ADDITIONAL INFORMATION:

On August 28, 2017, under Roll Call No. 17-1447, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Principal Park Batting Tunnel Building Expansion. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Principal Park Batting Tunnel Building Expansion, 11-2017-009. The improvement includes construction of a batting tunnel including deep foundations, Portland Cement Concrete (PCC) floor, masonry walls, steel frame, precast concrete deck, roofing, Exterior Insulation and Finishing Systems (EFIS) wall system, painting, sprinkler system, mechanical and electrical work and site restoration; all in accordance with the contract documents including Plan File Nos. 564-091/111, at Principal Park, One Line Drive, Des Moines, Iowa.
