AGENDA HEADING:

Resolution to approve and accept a permanent easement for pedestrian way across property located at 103 SW 3rd Street from Confluence on Third, LLC.

SYNOPSIS:

Recommend Council acceptance of real estate documents from Confluence on Third, LLC for properties located at 103 SW 3rd Street. This action is required for the acquisition of a Permanent Easement for Public Pedestrian Way from Confluence on Third, LLC, by Brian Roers, Manager, 1964 W. Wayzata Boulevard, Suite 200, Long Lake, MN, for \$73,719.

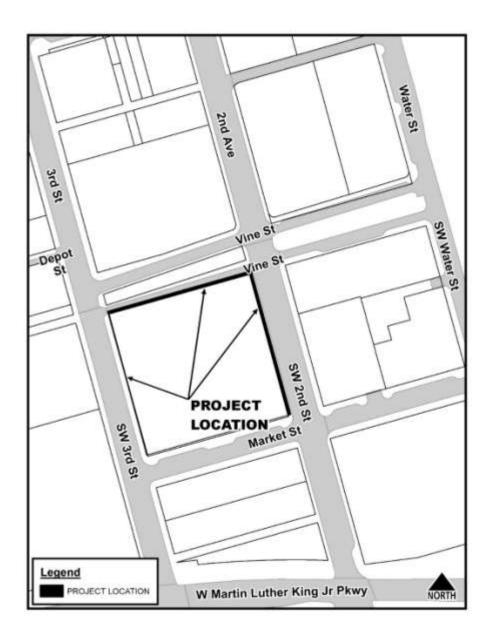

ADDITIONAL INFORMATION:

• Confluence on Third, LLC agreed to constructed Class A sidewalks along SW 2nd Street, SW 3rd Street, and Vine Street adjoining the property at 103 SW 3rd Street. The expanded public pedestrian way contains approximately 2,642.25 square feet of private land that is now being purchased for a permanent easement for the public pedestrian way. Confluence on Third, LLC is conveying this easement interest for \$73,719, which is equal to the fair market value of the property as determined by the City's Real Estate Division.
