**AGENDA HEADING:**

Approving agreement with MidAmerican Energy Company to replace the pedestrian lights with new LED lights for the 42nd Street Streetscape from I-235 to Crocker Street, not to exceed \$201,427.18.

**SYNOPSIS:**

Recommend approval of agreement between the City of Des Moines and MidAmerican Energy Company, 200 SE 3rd Street, Des Moines, IA, 50309, to replace the pedestrian lights with new LED lights for the 42nd Street Streetscape from I-235 to Crocker Street.
