AGENDA HEADING:

Approving Addendum to Lease Agreement with Atrium Finance III, LP, for relocation of parking for Embassy Suites.

SYNOPSIS:

Recommend approval of the Addendum to Lease Agreement with Atrium Finance III. The current Embassy Suites parking lease allows for relocation of the hotel's parking spaces. The Addendum memorializes the new location, as agreed upon by hotel and City staff. There are 55 hotel parkers that will continue to park in a temporary lot immediately east of City Hall, the remaining 94 will park in the new East Second Parking Garage.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- The new parking garage has been completed, and the City has taken possession of the garage for operation as the East Second Parking Garage. The City Manager has negotiated a Fourth Amendment to the Lease Agreement (the "Fourth Amendment") with Atrium to relocate the 94 on-street parking spaces into the East Second Parking Garage.
- There are 55 hotel parkers that will continue to park in a temporary lot immediately east of City Hall, the remaining 94 will park in the new parking garage at East Second Street and East Grand Avenue. The metered spaces on the Locust and Walnut bridges, formerly occupied by Embassy Suites during the garage construction, will be returned to regular on-street metered parking.
