AGENDA HEADING:

Public hearing for approval of the Proposed 2018 Action Plan for the U.S. Department of Housing and Urban Development (HUD) 2015-2019 Consolidated Plan.

SYNOPSIS:

The 2018 Action Plan is the fourth year of the 2015-2019 Consolidated Plan. It will be submitted to HUD for approval following final appropriations of Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) funds. The public hearing is an opportunity for residents to comment on how the City will use its federal funds.

FISCAL IMPACT:

<u>Amount</u>: Estimated \$3,403,924 (CDBG); \$733,582 (HOME); \$304,561 (ESG)

Funding Source: HUD
