AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Agreement for Professional Services with Terracon Consultants, Inc. for additional professional services for the Municipal Services Center (MSC) – Phase 2, for an additional amount not to exceed \$30,500.

SYNOPSIS:

Recommend approval of the Supplemental Agreement No. 1 to the Agreement for Professional Services with Terracon Consultants, Inc., Jeffrey Magner, Regional Manager, 600 S.W. 7th Street, Suite M, Des Moines, Iowa, 50309, for an additional amount not to exceed \$30,500, based on hourly rates, to provide additional environmental and geotechnical services for the MSC – Phase 2 project.

ADDITIONAL INFORMATION:

- On July 24, 2017, by Roll Call No. 17-1219, City Council approved the Professional Services Agreement with Terracon Consultants, Inc. for a total cost not to exceed \$30,450, based on hourly rates, to provide professional services.
- On July 24, 2017, building layout was still under design and all borings were utilized to define MSC Phase 2A (Fleet, Radio, and Sanitation Collections Division of Public Works) requirements only. MSC Phase 2B (Public Works) site will require investigation comparable to MSC Phase 2A.
- Also during environmental investigation, an area of concern was found on the Phase 2A site that requires additional borings for investigation and future monitoring if necessary.
- Staff has negotiated a Supplemental Agreement No. 1 to the Agreement for Professional Services with Terracon Consultants, Inc. for a total additional amount not to exceed \$30,500, based on hourly rates, to provide environmental and geotechnical services for the MSC Phase 2 project.
