AGENDA HEADING:

Recommend approval of an Amended and Substituted Police Services Intergovernmental 28E Agreement between the City of Des Moines and the Des Moines Skywalk Association.

SYNOPSIS:

Recommend approval of an agreement between the City of Des Moines and the Des Moines Skywalk Association for police services. The agreement specifies the level of security being provided by the Des Moines Police Department, compensation for services provided, and provisions for administration and modification of the agreement.

This Amended and Substituted Agreement takes the place of an agreement that was approved by the City Council on January 23, 2017. At that time, the Skywalk Association had agreed in principal on an agreement, but made objections to the final document after Council approval and was not signed or approved by the Skywalk Association. While this agreement is the same in terms of cost sharing, it provides more specifics regarding duties of an officer including an agreed upon Standard Operating Procedures.

FISCAL IMPACT:

<u>Amount</u>: \$61,049.48 - this is the amount that will be paid by the Skywalk Association in FY 2018 and represents one-half the total cost of one (1) Senior Police Officer position.

Funding Source:

ADDITIONAL INFORMATION:

- The Des Moines Police Department provides for one (1) Senior Police Officer position for patrol of the skywalk system during business hours. The agreement specifies that the Skywalk Association is responsible for one-half of a Senior Police Officer position salary and benefits at the top pay step and provides for additional staffing considerations if requested by the Association and agreed to by the Chief of Police. The agreement allows the City to adjust the monthly invoice amount to reflect any changes in compensation of the Senior Police officer position.
- The agreement replaces the prior agreement from 1996 and removes references to facilities no longer under the City's purview and to reflect current staffing levels provided by the Department.
