<u>Amount:</u> \$1,649,876 Construction Contract (\$2,800,000 City Engineer's Estimate)



ADDITIONAL INFORMATION:

- On December 4, 2017, under Roll Call No. 17-2039, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the MSC Demolition Contract 1.
